Mayor's Report

Mayor Milstead stated that there were 4 vacancies for Town Council for the election on May 3, 2016 and there were 3 candidates that have turned in their paperwork.

Manager's Report

John M. Slusser, Town Manager stated that William Lewis, Town Attorney has been appointed as judge for the Juvenile & Domestic Relations District Court and this will take effective as of July 1, 2016. Therefore we would need to search for another Town Attorney to replace him. William Lewis stated he had recommendations for the council.

Northern Neck Transmission property owned by John W. Hawkes, III and DeLinda Hawkes sale has been executed.

John M. Slusser, Town Manager stated that the VDOT grant was in Phase II and working on appraisals for easements.

Police Report

Interim Chief of Police Joan N. Kent stated that the monthly report was in the packet. We are working on accounting for the inventory in the evidence room and getting cameras installed. We have withdrawn the DMV grant and will reapply in 2017. There has been an ad placed in the paper to advertise for a Full Time Officer. The next Triad meeting will be March 22, 2016 at 9:30 a.m. at the Bay Transit Building.

Northern Neck Regional Jail Report

J. Lawrence Thorn reported the Northern Neck Regional Jail Board held their monthly meeting Wednesday, March 2, 2016. The population for this month was approximately 276 of which 133 were Federal Inmates and by the end of the day Federal Inmates had increased to 145. The NN Regional Jail is negotiating with the County of Gloucester and could bring about 130 additional prisoners which should resolve the water problem and looks very good for the Town of Warsaw.

Planning Commission Report

William L. Washington, IV, Vice Chairman for the Planning Commission stated that the Board of Zoning Appeals had referred to the Planning Commission the Application for Variance from Herbert Family Holdings, LLC at 141 Quail Trail.

The conditions were as follows:

- 1) The structure must be at least 100 ft. from the road, at least 25 feet from the rear property line, and at least 2 feet from the side property line.
- 2) The structure cannot exceed 1120 square feet.
- 3) The structure must be residentially compatible in appearance as determined by the Planning Commission and must be submitted for their approval prior to the issuance of a zoning permit.

4) The existing entrance/driveway must be used to access the structure.

This has been reviewed and signed off for approval.

Mayor Milstead stated there will be a meeting with Springsted on March 18, 2016 at 6:00p.m. to start the process for them to interview for hiring of a new Town Manager once they know what council would like in a new Town Manager.
